

## CONSUMER COMPETITION RULES

### “BUY NOARK PRODUCTS AND WIN A CELEBRATION BOX”

#### 1. COMPETITION ORGANIZER AND NAME OF THE COMPETITION

Noark Electric Europe s.r.o. with registered office in Prague 20, Sezemicka 2757/2, Post code: 193 00, Czech Republic, ID: 24123846, incorporated in the Commercial Register kept by the Municipal Court in Prague, Section C, File 10481 (hereinafter referred to as the “Organizer”) organizes via the website [www. xxxx.cz](http://www.xxxx.cz) owned by the organizer, a consumer competition called “Buy Noark products and win a celebration box” (hereinafter referred to as the “Competition”).

#### 2. VENUE AND TIME OF THE COMPETITION

The Competition takes place on the territory of the Czech Republic (hereinafter referred to as the “Venue of the Competition”) in the period from 5<sup>th</sup> April 2021 00:00:00 am to 31<sup>st</sup> October 2021 11:59:59pm (hereinafter referred to as the “Duration of the Competition”). “). For the purposes of evaluating the Competition, the Competition is divided into 8 individual separately evaluated competition days, with the fact that the competition day for the purposes of this Competition means the first day of the following month. (hereinafter referred to as the "Competition Day").

#### 3. CONDITIONS OF PARTICIPATION AND MECHANICS OF THE COMPETITION (mechanika?)

Any person (hereinafter referred to as the "Contestant") with a delivery address in the Czech Republic may participate in the competition. The competition is intended for people over 18 years old. A competitor becomes a person who meets all the conditions of the competition set out in these rules. Competitors will buy one-time (for one tax document) any NOARK competitive product in any retail, wholesale or e-shop in the place and time of the competition and will keep proof of this competitive purchase (hereinafter referred to as "Competitive Purchase"). The contestant is obliged to keep all documents on the execution of the competition purchase, which he participated in the competition, until the settlement of the Prizes in the Competition. In the case of a win, the draw contestant will be invited to submit all documents with which they participated in the competition.

For the avoidance of doubt, it is stipulated that in the event that it is possible to make a proof of the competitive purchase meeting the conditions of these rules, send scans / photographs of tax documents from electronic cash registers / invoices from which the relevant Competitive Purchase will be clearly performed - the name of the Competition Product, the date and time of the Competition Purchase, the total amount in CZK, BKP code (all 44 characters) / the whole invoice number in case of purchase on invoice / document number in case of purchase on abbreviated receipt will be printed legibly. If the Competitor does not submit the above documents, he will not become the winner and his new competition registration will exclude them from the competition. Then he will be replaced by a substitute winner. This procedure will be repeated a maximum of 1 (see Additional draw below). If this procedure does not determine the winnings in the competition, the win will be forfeited by the organizer, who is entitled to decide on further use.

The cash register systems of some business partners may offer abbreviated versions of tax documents without a statement of purchased items. These documents regard to the above, it is not possible to register these tax documents for the competition, because in the case of a draw it is not

possible to prove the fulfillment of the competition conditions and thus to confirm to the competitor the right to win.

After purchasing the Competition Product, the Competitor will visit the website [www.xxxxx.cz](http://www.xxxxx.cz) during the Competition, where he will register for the competition as follows:

1. Uploads a photograph (scan) of the receipt / invoice (which proves the purchase of the competition product). Upload the receipt / invoice either via the "Drag file" option or upload the photo then save and upload the receipt photo via the "Browse your device" option. The maximum size of photo is up to 5 MB and PNG, JPG or GIF format.
2. Then fill in the required data - name, surname, company, e-mail address, full delivery address and telephone number.
3. Each individual contestant may upload any number of unique receipts / invoices to one email address between individual competition days. If an already registered document is uploaded when attempting to register for the competition, this receipt / invoice will not be included in the competition. To successfully complete the registration, the Competitor confirms that he has read the rules of this competition and undertakes to comply with them, is a person over 18 years old and that he voluntarily expresses his express consent to the processing of personal data to the extent specified by these rules.
4. The competition registration is completed after approval via the "SEND" button.
5. The contestant is informed about the successful competition registration by a message displayed on the screen of the device from which the registration was made.

In(at) the moment of successful competition registration, the competitor (or the receipt / invoice uploaded by him) is included in the competition on the relevant competition day. Each competition day is evaluated completely separately. Competition registrations registered for the competition on a specific competition day will not be moved to the following competition days.

Each individual contestant may participate in the competition with only one specific e-mail address.

Repeated participation in the competition is always conditioned by a new competition registration, i.e. another competitive purchase, and proper competitive registration of a new receipt / invoice.

#### **4. WIN, DETERMINATION OF WINNERS AND ADDITIONAL DRAWING**

##### **WIN**

The prize in the Competition is an annual gift box, which contains xxxxx (above and hereinafter as "Win")

A total of 10 prizes are entered into the competition.

Winners in the competition will be selected by random drawing, made at the organizer's place. This draw will take place no later than 3 working days after the end of the competition. Winners are notified of the prize by e-mail provided in the registration form via [xxxx@noark-electric.com](mailto:xxxx@noark-electric.com) no later than 1 week after the end of the competition. In the event, that the competitor has not met the conditions of this competition, he loses the right to the win and it is forfeited in favor of the organizer, who is entitled to decide on its further use.

##### **TRANSFER OF WIN**

The prize will be sent to the winner by post to the address he / she stated as delivery address during registration or handed over in person by a NOARK sales representative. The prize will be handed over no later than 4 weeks after the end of the competition day.

## **5. GENERAL DATA PROTECTION REGULATION**

By submitting the registration form for the competition, the competitor confirms that he voluntarily agrees with the rules of this competition and confirms that he has read them and that he is acting in accordance with them. Furthermore, the competitor gives the explicit consent with the recording of the textual content of the data provided in the registration, name, surname, e-mail address, delivery address and phone number. Contestants agree to receive information emails or phone contacts regarding this contest. The competitor agrees to the possible publication of his personal data in the range - name, first letter of surname and the name of the town (for example: Jan N., Prague) on the winning list, which may be published on the competition website or other communication channels of the competition organizer. The competitor consents to the processing of personal data to the extent specified below.

By sending the registration form, the competitor agrees to the processing of personal data to the extent of provided personal data (hereinafter also "Data") and their inclusion in the Organizer's database, for the time strictly necessary for the purpose of processing, but no longer than 2 years unless this consent has been revoked earlier. The personal data of the competitors processed are as follow: name, surname, company, e-mail address, delivery address, phone number.

The contestant may revoke this consent at any time by e-mail to [xxxx@noark-electric.com](mailto:xxxx@noark-electric.com) or by delivering a written appeal to the company's registered office. By revoking his consent, the competitor will be excluded from the competition, and at the same time he loses the right to win in the competition.

The competitor acknowledges that he has the rights guaranteed by the Regulation of the European Parliament and of the Council (EU) on the protection of individuals with regard to the processing of personal data (hereinafter the "Regulation") and Act No. 101/2000 Coll., On the protection of personal data, in valid wording (hereinafter referred to as the "Act"), in particular that it has the right of access to personal data, the right to correct such data, block incorrect data, their disposal, etc.

Personal data are processed mainly for the registration of competitors, for the period from their provision within the competition until the announcement of the results of the competition, or more precisely, until a possible written withdrawal of consent, but for a maximum of 2 years from their provision. Personal data is obtained from the contest participant on the basis of the registration form. The personal data of the contest participant will be processed to the extent specified in the administrator's electronic database.

If a participant in the competition requests information about the processing of his personal data, the administrator and possibly also the processor is obliged to provide this information without undue delay. Administrator, or more precisely, the processor shall provide the information for free unless the request is manifestly unjustified or unreasonably repeated.

Any participant who discovers or believes that the controller or processor is processing his personal data which is contrary to the protection of the privacy and personal life of the contestant or contrary to the law, in particular if the personal data are inaccurate with regard to the purpose of their processing, it may ask the controller or processor for an explanation or request that the controller or

processor remove the situation thus created (blocking, correcting, supplementing or disposing of personal data). The Contestant also has the right to address his / her legitimate requests to the administrator or processor, and if they do not comply with them, he can directly contact the Office for Personal Data Protection. The contestant may revoke this consent at any time by e-mail to [xxxx@noark-electric.com](mailto:xxxx@noark-electric.com) or by delivering a written appeal to the company's registered office. By revoking his consent, the competitor will be excluded from the competition, and at the same time he loses the right to win in the competition.

## **6. OTHER CONDITIONS OF THE COMPETITION**

The e-mail address provided by the competitor in the registration form is considered by the organizer to be the e-mail address of the competitor. Each individual contestant can participate in the competition with only one specific e-mail address - if the organizer finds out otherwise, such contestant will be excluded from the competition without compensation.

Contestants participate in the contest with the knowledge that they are not entitled to demand cash or any other performance instead of the prize. The organizer is not otherwise obliged to the competitors who participate in the competition and they are not entitled to any other performance by the organizer than those specified in these rules.

Each contestant can get a maximum of 1 prize in one competition day. At the same time in the event, that two or more competitors have the same surname (a variant of the masculine form in the masculine gender is also considered to be the same surname) and at the same time fill the same delivery address in the registration form, such competitors are considered members of one family. Only one member from each family can win the prize (in the sense of the previous sentence); in the case of more family members participating in the competition, the prize will be handed over only to the person who was entitled to win in the competition earlier (who was previously drawn).

The promoter reserves the right to replace the declared winnings with winnings of a similar type and corresponding value and to change the conditions for the transfer of winnings, especially if the winnings are not provided to a third part so that they can be awarded to the winners in accordance with these rules. Winnings are not legally enforceable. Unclaimed prizes are forfeited to organizer.

The organizer is not responsible for non-delivery of the registration form, providing incorrect or inaccurate information in connection with the competition (whether caused by human factors or technical defects), for any technical difficulties or defects arising during the competition, speed of technical connection or other possible deficiencies in connection with competitions or in connection with the Internet network or its availability for competitors.

The organizer decides definitively on any complaints or objections. The organizer reserves the right to shorten, postpone, interrupt, cancel or unilaterally change or supplement its rules for the entire duration of the competition without compensation, by announcing the change on the competition website [www.xxx.cz](http://www.xxx.cz) and [www.xxx.cz](http://www.xxx.cz), where the Full Rules of the Competition are also available.
